SECTION 4: First aid measures

4.1 Description of first aid measures

General advice : Move out of dangerous area.



- Consult a physician.
Show this safety data sheet to the doctor in attendance.

SECTION 5: Firefighting measures

5.1 Extinguishing media

- Suitable extinguishing media : Alcohol-resistant foam, Carbon dioxide (CO₂), Dry chemical
- Unsuitable extinguishing media : Water, High volume water jet

5.2 Special hazards arising from the substance or mixture

- Specific hazards during fire-fighting : Do not use a solid water stream as it may scatter and spread fire. Do not allow run-off from fire fighting to enter drains or water courses.

5.3 Advice for firefighters

- Special protective equipment for firefighters : In the event of fire, wear self-contained breathing apparatus.

7.1 Precautions for safe handling

Advice on safe handling : Do not breathe vapours or spray mist. Avoid exceeding the given occupational exposure limits (see section 8). For personal protection see section 8. Smoking, eating and drinking should be prohibited in the application area. Take precautionary measures against static discharge. Open drum carefully as content may be under pressure.
